Upcoming Detachment/Annexation Hearing

- Maas case (Warsaw/Mendon)
 - o Discussed the background of this case.
 - o Denied original petition.
 - o Indicated intent to submit a new petition with a land swap.
 - o They do not intend to use an attorney
 - o Maas family have been engaged with both school districts.
- Pershing case (Southeastern/West Prairie)
 - o Pershing submitted a petition and a hearing was scheduled
 - o Southeastern attorney sent a letter indicating opposition.
 - o Pershing decided to withdraw original petition and have indicated they are working on revising with a land swap before re-submitting to the board.
 - o A property a couple parcels north of the Pershing parcel is a noncontiguous parcel in the Southeastern school district. It is an island in the middle of the West Prairie school district.

Consolidated Election – Tuesday, April 6, 2021

- o Regional board members are elected to six year terms.
- o G White and B Zimmerman term ending.
- o B Zimmerman indicated interest and intent to run for the open seat.
- o G White indicated interest but open to other candidates if interest is known.
- o J Meixner will share information with both B Zimmerman and G White on the process.

Update on ROE26 Operations

- Start of school has been a mix bag the way districts have returned to instruction.
- Some schools going full remote, some are in a hybrid model, while a majority are in person with remote being an option.
- ROE26 ROYALS staff are managing the full remote students from the Macomb school district through the online platform, Edgenuity. Staff is currently helping manage 150-160 students.
- ROE26 Royals program are in a hybrid model varying to some degree depending on location.
- ROE26 services for the most part are still required and being done. Health Life Safety inspections start this week, compliance has started, truancy has changed but still engaged, and other requirements districts are still being asked to do are being verified.
- ROE26 has had one + case of covid19. That individual followed guidelines set forth and two additional employees were quarantined because of direct contact with that individual. Those quarantines have expired and all three are doing well and back to work.
